MEETING – SEPTEMBER 7, 2010

The Mullett Township Board of Trustees met at the Mullett Township Hall on September 7, 2010. at 8:00pm. All Board Members were present: Willard Morgan, Rachel Osborn, Karen Morgan, Dennis Dombroski, and John Brown.

Dennis Dombroski led the meeting with the Pledge of Allegiance.

The minutes of the August 5, 2010 meeting were read and approved as read with a motion by John Brown and seconded by Dennis Dombroski. Motion passed Open Forum included: Tom Ohare, Carl Muscot, Babs Naylor, Mr. Jonski Bob English, Topinabee Fire Chief brought several bills to the boards attention and wants the Mullett Township Board to think about converting all of the Mullett Townhall into a fire hall because they need more space.

There was a motion to approve new pagers for the new Topinabee Fire Department members made by Dennis Dombroski and seconded by John Brown, motion passed.

Babs Naylor, a member of the Friends of the Library which did a great reading program this summer wants to do different signs for next summer.

Mr. Jonski wants Patterson Road repaired.

Dennis Dombroski made a motion to create a new line item to be called Contracted Services in the budget and fund with the amount of \$10,000.00 to start the 101101801 account number. Seconded by John Brown and motion passed.

Karen Morgan made a motion to purchase an outdoor bulletin board for the Mullett Township

Hall for posting meetings and general information. Seconded by John Brown and motion passed.

Bill Morgan will look into purchasing some type of fence to protect the sidewalk near the public restrooms

John Brown will research the cost of solar lights for the public docks.

Motion made by Dennis Dombroski to increase the grant amount for the library USDA, RA in the amount of \$69,350.00, seconded by John Brown, motion passed.

Motion by Dennis Dombroski to approve an amount of \$100,000.00 for the TIGER II Grant seconded by John Brown, motion passed.

John Brown made a motion to increase the line item 206336741 (turn out gear) in the amount of \$12,000.00. Seconded by Dennis Dombroski, motion passed.

Clerk will need to void Check number 14117 in the amount of \$380.00 made out to the Cheboygan County Fire Fighters Association.

Registration for the MTA January Conference which will be held on January 26 – 28, 2011 will be attended by Rachel Osborn, Karen Morgan, Dennis Dombroski, John Brown, Helen Zimmer and Teresa Schepperley. Registration starts on October 1, 2010.

Motion to approve \$750.00 to contract Cheboygan County Humane Shelter to pick up stray dogs and cats and etc. in Mullett Township made by Bill Morgan, seconded by Karen Morgan. Motion passed.

Bill Morgan called the meeting to a closed session at 9:30pm to discuss pertinent information with the board until 10:15 pm.

Motion to pay the bills made by John Brown and seconded by Dennis Dombroski. Motion passed.
