The Mullett Township Board of Trustees met at the Mullett Township Hall in Topinabee, Michigan on December 5, 2017 at 7:00 p.m. All Board Members were present: Hobart Kirsch, Rachel Osborn, Kathy Flory, Dennis Dombroski and John Brown.

The meeting was opened at 7:00 pm., with the recitation of the Pledge of Allegiance.

Public Comment was opened at 7:01 p.m. with Mary Jo Welsh, Tom O'Hare and Ken Hoehne suggesting the board look into passing a blight ordinance to address blight issues in downtown Topinabee. Also, a street light is missing on the corner of Lea and Portage in Topinabee.

John Brown motioned to approve the minutes of November 7, 2017 with a second by Kathy Flory, motion passed.

This letter honored the fire department for their service to Mullett Township and thanked them for their dedication. The letter was signed by Governor Snyder. The certificate will be framed and put in the Mullett Township Hall .

Hobart Kirsch signed the Charter Communications franchise since it is not an exclusive contract which will allow other companies to come into Mullett Township and offer service to our residents.

By consensus, the board decided to set the budget meeting for February 12, 2018 at 6:00 p.m.

On a motion by Dennis Dombroski to set the clean-up days for August 4, 2018 in Topinabee and August 11, 2018 on Derby Road, with a second by John Brown, motion passed.
