

MULLETT TOWNSHIP BOARD OF TRUSTEES MINUTES FOR  
AUGUST 14, 2018 – 7:00PM – MULLETT TOWNSHIP HALL  
TOPINABEE, MICHIGAN 49791

The Mullett Township Board of Trustees met at the Mullett Township Hall in Topinabee, Michigan on August 14, 2018 at 7:00 p.m. All Board Members were present: Hobart Kirsch, Rachel Osborn, Kathy Flory, John Brown and Dennis Dombroski.

The meeting was called to order with the Pledge of Allegiance being recited by all in attendance.

Public Comment was opened at 7:01 p.m. with comments regarding the recycling agreement with Cheboygan County: blight ordinance and library. All written comments will be maintained in the record.

Public Comment was closed at 7:20 p.m.

A motion offered by John Brown and supported by Kathy Flory to approve the minutes of the July 10, 2018 meeting was passed.

Dennis Dombroski motioned to sign the five year agreement with Cheboygan County for Mullett Township's participation in the Recycling Program for the years 2018-2022, Kathy Flory seconded and the motion was passed.

On a discussion of the Public Launch at Woodruff: Hobart Kirsch will be asking the Cheboygan County Road Commission how they might propose to fix the power loading problem which is occurring and causing an accumulation of sand on top of the new ramp used for launching

The Board spent time marking up the old "Blight Ordinance" with a discussion of how to best go forward with funding, process, and implementation.

A Resolution to oppose House Bill 6049 and Senate Bill 1025 which will change how assessing is done at the local level was passed with a roll call vote: Ayes: John Brown, Dennis Dombroski, Hobart Kirsch, Kathy Flory and Rachel Osborn. Nays: None Absent: None

John Brown nominated the following people to serve on the "Old School House" Committee: Rachel Osborn, Chair: Patty King, Joyce Stroman, Karen Magee, Cindy Poquette and Linda Miller, with a second by Kathy Flory, motion passed.

Letters from Penny Kent, Bob Scillion and Peggy Rapple were read into the record.

Rachel Osborn motioned to amend the budget for 2018-2019 as follows: Add on the revenue side the account number 206336698 known as Loan Proceeds in the amount \$160.00: Add on the expense side the account number of 206901970 known as Capital Outlay in the amount of \$360,000.00, seconded by Kathy Flory, motion passed.

Hobart Kirsch motioned to pay the bills with a second by John Brown, motion passed.

Meeting adjourned at 9:30 p.m.
