MULLETT TOWNSHIP BOARD OF TRUSTEES

The Mullett Township Board of Trustees met at the Mullett Township Hall in Topinabee, MI, 49791 on February 14, 2022, following the 2022 Annual Meeting of Electors. The meeting was called to order at 6:45 PM with the recitation of the Pledge of Allegiance. Members present were Supervisor Laz Surabian, Clerk Denise Ackerman, Treasurer Brenda Bowes, Trustee Mike Goerke, and Trustee Brett Lindgren.

Public Comment was opened at 6:46 PM and closed at 6:46 PM with no comments

Brett Lindgren made a motion, with support by Brenda Bowes, that the agenda be approved. The motion passed.

Brenda Bowes made a motion, with support by Mike Goerke, that the minutes of the January 10, 2022 meeting and the minutes of the February 7, 2022 Budget Workshop be approved. The motion passed.

Mike Goerke made a motion, with support by Brett Lindgren, that we pay the bills. The motion passed.

The Treasurer reported to the Clerk that all accounts were balanced for the month of January.

Mike Goerke reported that the Website is still waiting for the .gov designation before going live.

Topinabee Fire Chief Mike English made his monthly Fire Report, reporting 5 runs (1 EMS and 4 Fire) for January; 3 in Mullett Township, 1 in Burt Township, and 1 Mutual Aid

East Mullett Fire Chief John Parrott sent a report of 1 EMS runs for January, along with his yearly report for 2021 indicating 35 runs; 26 for EMS and 9 for Fire.

Denise Ackerman made motion, with support from Brenda Bowes, that the Board approve an expenditure of \$1300 for renewal of the Library's Alexandria support upgrade. The motion passed.

## **OLD BUSINESS:**

- During the February 7, 2022 Budget Workshop the Board approved putting the Woodruff Launch and Dry Hydrant Project out for rebid.
- Brett Lindgren made a motion, with support from Brenda Bowes, that we sign the contract with Cheboygan County Humane Society for Animal Control Services in the amount of \$750. The motion passed.

## **CURRENT BUSINESS**

- A motion was made by Brenda Bowes, with support by Mike Goerke, that the following increases be made to the employee pay structure in Mullett Township: Library Director from \$15/hour to \$18/hour; Liquor Inspector from \$110/month to \$150/month; Fire Chief runs first hour from \$40/hour to \$50/hour; Asst Fire Chiefs first hour from \$30/hour to \$40/hour; Fire Officers from \$20/hour to \$30 hour; Firefighter training from \$10/hour to \$15/hour; Election Manager from \$15/hour to \$20/hour; and Election Inspectors from \$13/hour to \$15/hour. The motion passed.
- Motion was offered by Clerk Denise Ackerman, with support from Treasurer Brenda Bowes, that the Board codify our current Policy for Post-Audit Authorization for Certain Claims. The motion passed.

Call to the Public was called at 7:26 PM and closed at 7:29 PM with one comment.

Motion to adjourn was offered by Brett Lindgren, with support by Brenda Bowes, at 7:32 PM. The motion passed.
