MULLETT TOWNSHIP BOARD OF TRUSTEES
MEETING FOR MARCH 14, 2022
6:30 PM AT MULLETT TOWNSHIP HALL

The Mullett Township Board of Trustees met at the Mullett Township Hall in Topinabee, MI, 49791 at 6:30 PM on March 14, 2022. The meeting was called to order at 6:30 PM with the recitation of the Pledge of Allegiance. Members present were Supervisor Laz Surabian, Clerk Denise Ackerman, Treasurer Brenda Bowes, and Trustee Mike Goerke. Trustee Brett Lindgren was absent.

Public Comment was opened at 6:31 PM and closed at 6:32 PM with one comment.

Denise Ackerman made a motion, with support by Mike Goerke, that the agenda be approved with one addition to New Business. The motion passed.

Brenda made a motion, with support by Mike Goerke, that the minutes of the February 14, 2022 meeting be approved. The motion passed.

Brenda Bowes made a motion, with support by Denise Ackerman, that we pay the bills. The motion passed.

At 6:37 PM the Open Public Hearing for Budget for Fiscal Year April 1, 2022 – March 31, 2023 was opened.

Details for each Fund was discussed, with questions from the public fielded. **Mullett Township General Appropriations Act for Fiscal Year 2022-2023, Resolution 2022-07** was read into the record with the following details:

Topinabee Asst Fire Chief Brian Coffell made the monthly Fire Report, reporting 7 runs (3 EMS and 4 Fire) for February; 5 in Mullett Township, 1 in Burt Township and 1 mutual aid.

East Mullett Fire Chief John Parrott reported of 1 EMS run for February.

OLD BUSINESS:

- Bids for the Woodruff Launch and Dry Hydrant Project will be opened Friday, March 18, 2022 at 2:00 PM.
- Burt Township has agreed to split the cost of the fog lines on S Extension Rd.

CURRENT BUSINESS

- Tabled the rescinding of the Old Blight Ordinance.
- Motion was made by Brenda Bowes, with support by Denise Ackerman, for Mike Goerke to sell the Server Rack purchased in error for best price and it in the Old School House until sold. The motion passed.
- A motion was made by Brenda Bowes, with support by Denise Ackerman, that only one representative get paid for attending the Burt Trail Committee. The motion was split.
