MULLETT TOWNSHIP BOARD OF TRUSTEES

MEETING FOR JULY 8, 2024

6:30 PM AT MULLETT TOWNSHIP HALL

The Mullett Township Board of Trustees met at the Mullett Township Hall, Topinabee, MI, at 6:30 PM on July 8, 2024. The meeting was called to order at 6:30 PM with the recitation of the Pledge of Allegiance. Members present were Clerk Denise Ackerman, Treasurer Brenda Bowes, Trustee Brett Lindgren, and Trustee Mike Goerke. Supervisor Laz Surabian was absent. Also present were Mullett Township Fire Chief Mike English and Library Director Judy Jacalone. There were 5 constituents present. Public Comment was opened at 6:32 PM and closed at 6:36 PM with one comment.

Brenda Bowes made a motion, with support by Mike Goerke, that the agenda be approved. The motion passed.

Brett Lindgren made a motion, with the support of Brenda Bowes, that the minutes of the June 10, 2024, meeting be approved. The motion passed. Brenda Bowes made a motion, with support by Denise Ackerman, that the minutes from the Mullett Township Election Commission of June 10, 2024, be approved. The motion passed.

Brenda Bowes made a motion, with support Brett Lindgren, that we pay the bills. The motion passed.

Brett Lindgren made a motion, with support by Brenda Bowes, that the Clerk's report be accepted and filed. Motion passed. The Treasurer reported to the Clerk that all June accounts were balanced.

Mullett Township Administrative Fire Chief Mike English made the monthly Fire Report for Topinabee Fire Department, reporting 13 runs – 9 fire & 4 EMS for June: 9 in Mullett Township, 3 in Burt Township and 1 Mutual Aid. He also reported 0 fire runs for the East Mullett Fire Department in June.

The Board was updated on maintenance issues in progress: bathroom doors in Topinabee Park should be installed the week of July 8th ; Woodruff Knott weed remediation was June 26th; new oven for East Mullett Hall has been installed; repair and trimming of Southerland stairs completed; new sign installed at East Mullett Fire Department; Dump Days signs erected; working on basketball posts at Schoolhouse Park; Library patio weeding and touchup painting in process; handicap water access pad at Topinabee Park repair also in process

OLD BUSINESS

- **Boy Scout Park:** Reviewing bids for Quonset Hut repair/replacement, with two more expected.
- **Topinabee Boat Launch:** Mike Goerke made a motion, with support by Brett Lindgren, that the MAPS signage be installed between the two existing signs on the lake side. The motion passed.
- **Blight:** Mike Goerke made a motion, with support by Brenda Bowes, that the complaint on Property O on Topinabee Mail Route Road be forwarded to the Sherrif as blight. The motion passed.

NEW BUSINESS

- **Assessor Request:** The Board will extend an invitation to Assessor McGovern to discuss his request for assistance.
